

NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN of a public hearing to be held before the Plan Commission of the Village of Lake Barrington as follows:

HEARING DATE AND TIME: April 28, 2011 at 7:00 p.m., or as soon thereafter as the agenda permits.

PLACE OF HEARING: Village of Lake Barrington Village Hall, 23860 Old Barrington Road, Lake Barrington, Illinois.

NATURE OF HEARING: The Petitioner is requesting consideration of a petition for a special use permit which would allow a vehicle repair service to be located and operated at 28022 W. Industrial aka 28034 W. Industrial Avenue, Unit 2, Lake Barrington, Illinois. The subject property is located in the M Manufacturing and Industrial Zoning District. Section 8-4-6(C), "M Manufacturing and Industrial District", of Chapter 4 of Title 8 of the Village of Lake Barrington Village Code, allows a vehicle repair service and garage in an M District, but only if such a Special Use is approved by the Board of Trustees.

COMMON ADDRESS OF PROPERTY: 28022 W. Industrial Avenue aka 28034 W. Industrial Avenue, Unit 2, Lake Barrington, Illinois.

LEGAL DESCRIPTION OF THE SUBJECT PROPERTY:

THE EAST HALF OF LOT 6 IN LAKE BARRINGTON INDUSTRIAL SUBDIVISION, UNIT #2, BEING A SUBDIVISION OF PART OF SECTIONS 21, 22, 27, AND 28, ALL IN TOWNSHIP 43 NORTH, RANGE 9, EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED MARCH 14, 1968, AS DOCUMENT 1371277, IN BOOK 44 OF PLATS, PAGE 52, IN LAKE COUNTY, ILLINOIS.
